California Division of the Department of Transportation (DOT), the appellant, appeals from an order of this court dated January 11, 1984 granting the motion to dismiss the complaint of the debtors, appellees herein, Michael and Nancy Sills. The issues raised by the appeal involve the Constitutional issues of a State taking property under the Bankruptcy Clause, U.S. Const., Art. IV, § 1, (Supreme Court decision in *The New York v. New York, New Haven & Hartford R. Co.*, 344 U.S. 293, 73 S.Ct. 299, 97 L.Ed. 333 (1953)) and abridgement of the sovereignty of the United States under the Tenth Amendment to the U.S. Constitution. The facts are not in dispute. After an evidentiary hearing on November 7, 1983, it was determined that the debtors had overstated their disposable income and were entitled to a hardship discharge of their federal loans. On December 21, 1983 the debtors received a discharge of the student loan debts pursuant to 11 U.S.C. § 523. On January 11, 1984 a discharge was granted on the remaining secured claim of the California DOT. The debtor's motion to dismiss the complaint was heard by this court on February 7, 1984, and on February 9, 1984 an order was entered dismissing the complaint of the DOT.
